**Glenluce Nursery** - shelving, signage, waterproof jackets, trousers and wellies. It was unanimously agreed not to make any award after last month' agreement to make available an annual grant of £1,500.00 to Glenluce Primary School (amount to be reviewed after three years). Fred had spoken to the chair of New Luce Community Council who had advised that New Luce had previously made available an annual grant of £1,500.00 to Glenluce Primary School.
